05. Attested copies of completed and work in Progress Certificates together with non-refundable processing fees of Rs. 5,000/- (Rupees Five thousand) only by D.D. payable to M/s. Consultants Combine Pvt. Ltd.
06. Solvency Certificate from Bank should have – Solvency of 40% of the project value.
