In case of necessity, the bidder(s) may be asked to submit all original documents against the aforesaid points. C.M.C shall verify the authenticity of the original document.

#### **Part-II : Price Bid:**

The price schedule as per the format indicated in the Bid Price Schedule. The bidder shall quote the rate for all items , **Highest offered rate for the item will be considered during evaluation of bids.** In this respect decision of the authority will be final.

5. In case the above scheduled last date for receiving of auction offer against N.I.A. is declared holiday by the State Government, the said N.I.A. will be received up to 3.0 PM on the next working day keeping other clauses of N.I.A unchanged.
6. If any auction bidder withdraws his offer before the said period or makes any modifications in the terms and conditions of the auction offer which are not acceptable to the C.M.C, the C.M.C shall without prejudice to any other right or remedy, be at liberty to forfeit the said earnest money absolutely

The auction/tender bid document shall be available only in the website as mentioned above and accordingly needs to be downloaded by the intending bidder. **While dropping of the downloaded auction /tender bid, it must be accompanied with the requisite cost of the bid form (Auction free Rs. 1000/-). Non submission of cost of tender/auction form and EMD will be treated as non responsive and shall be liable for rejection.** During submission

/dropping of the auction/tender, each and every page of NIA document should be signed with seal and will be enclosed with the Pre-qualification bid.

7. The bidder shall be required to deposit earnest money put to NIA in the shape of Demand Draft / Banker Cheque in favour of Chandernagore Municipal Corporation on any Nationalized / Scheduled ICICI Bank along with the bid in a separate sealed envelope. The earnest money deposited shall be adjusted while deposit of sale value. Earnest money will not be refunded before finalization of the process and in no case no interest will be paid for earnest money deposit.

8. Auction bids shall be dropped in tender box up to 3.00 PM in the office of the MAYOR, Chandernagore Municipal Corporation. Delay in receiving bids by post / courier shall not be considered beyond stipulated time and date.
9. The pre-qualification bid shall be opened on the same day if possible; otherwise the pre-qualification bid shall be opened on the next working day.
10. The bid shall be valid for a minimum period of 180 (One hundred and eighty) days from the date of opening of the tender.

## **Terms & Conditions for the purpose of distribution of lease for the motor launch service between Chandernagore Ranighat & Jagaddal under the Jurisdiction of Chandernagore Municipal Corporation.**

e-auction is invited for the sanction of lease for the ferry Service, mentioned above under the terms & Condition.

1. a. Tender amount of Ranighat-Jagaddal Ferry Service for the year 01.09.2017 to 31.08.2020 (three Years) is fixed as Rs. 40 lakhs.
2. Documents to be submitted at the time of Technical Bid as follows:
  - a) Self attested current Photo & Photo identity Card of interested bidders and the signature is also attested by the Councillor/Mayor/Commissioner.
  - b) Residential Certificate from a gazetted officer or any other person who has office seal.
  - c) Document of submission of income Tax/ Professional Tax/GSTIN.
  - d) Experience certificate/Documents related to ferry Service.
  - e) List of bidder's property, i.e.- Mouza, J.L. Dag No., Khatian No., Quantity of property, Land demarcation, Bank Account details.
  - (f) Bidders should submit online Rs., 80 thousand, in favour of CMC, with other documents as earnest money online.
3. Cooperatives related to Ferry Service may also take part in Tender process.
4. 25% of selected bid rate will be deposited through Bank Draft in favour of CMC at time of confirmation. Remaining amount will be deposited by the highest bidder in four equal installments within one year. Either the lease agreement will be cancelled and the caution money will not be refund and another Tender Notice will be published.
5. The person/institution, whose bid will be selected enter into an agreement within 15 days with the Chandernagore Municipal Corporation, at their own cost.
6. The Highest bidder must deposit amount as bank guarantee for three years in a 1 (One) year proportionately, otherwise his lease will be cancelled.

- (ii) Places of Step in or Step out of passengers, Ferry Ghat, and the way to ferryghat of the both the side of the river will be maintained well by the leasee on his own contribution.
  - (iii) There will be rest room for the passengers both the side of the ferryghat.
  - (vi) Price chart must be there both the side of the river on a printed wooden board in a open place by the leesee at his own cost.
  - (v) Without permission of CMC, leasee never handover the ferry service to anybody.
  - (vi) If any situation comes to face accident due to natural calamity or any other cause, ferry service must be postponed, neither CMC will be responsible for the loss nor human beings or their articles.
  - (vii) Leasee will be ready to obey the Instruction of CMC.
  - (viii) Employees related to ferry service, must submit their Photo Identity Card and Duty Roaster to CMC.
17. Leasee will be ready to transport the following items or persons without any charges.
- (i) Posts, postal vehicles, peon , when they use the ferry for their official purpose.
  - (ii) Vehicles, animals, articles of Commiserate, with its chalan.
  - (iii) Defense personnels, soldiers and other items or animals attached to them for the sake of official purpose.
  - (iv) Police, public servant, summons bearer and other people attached to them with other articles or animals use the ferry for the official purpose.
  - (v) CMC authority, members, staffs use while official duty.
  - (vi) Carriers of Dead Body and property sent by the Police.
  - (vii) child below three years.
  - (viii) Loaded Vehicles along with driver with articles of CMC, with the order of authority carried by staffs.
18. CMC will not be responsible for the compensation of Ferry ghat/jetty/boat damaged by accident.
