6) The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 3 (Three) year from the date of successful completion of the work to the entire satisfaction of the Authority. If any defect / damage are found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect. Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned above for 3 (Three) year from the date of completion of the work. Terms and Conditions of Chandernagore Municipal Corporation shall be treated as superseded. Vide Order No-592/1(125)/MA/C-10/3S-21/2013 dt. 28 day of October 2016.

10) The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The tender accepting authority of Chandernagore Municipal Corporation reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.

11) **Refund of EMD:-** The Earnest Money of all the **unsuccessful Tenderers** deposited in favour of "Chandernagore Municipal Corporation" payable at Chandernagore will be refunded online.
