


Terms & Conditions:-

- (ii) Credential :- Tenderer (a) having successfully completed similar nature of job with the contract of Value not less than 40% of the value put to Quotation in one single contract during last 5 (five) years prior to the date of this tender notice or (b) having successfully completion of similar nature of jobs of value not less than 30 % of the value put to Tender in each of two separate contract during last 5 (five) years prior to the date of this Tender notice or (c) intending Tenderer should produce credential of one single running work similar nature of contract jobs which has been completed to the extent of 80% or more the value put to Tender and each under an Govt./Govt. undertaking /Autonomous Body/Local Body. In case of running works certificate should be clearly stated that the work is in progress satisfactorily and no penal action has been initiated against the executing agency i.e. Tenderer.
